GENERAL INFORMATION: Tax Code Section 26,04(c) requires an officer or employee designated by the governing body to calculate the no-new-revenue (NNR) tax rate and voter-approval tax rate for the taxing unit. These tax rates are expressed in dollars per \$100 of taxable value calculated. The calculation process starts after the chief appraiser delivers to the taxing unit the certified appraisal roll and the estimated values of properties under protest. The designated officer or employee shall certify that the officer or employee has accurately calculated the tax rates and used values shown for the certified appraisal roll or certified estimate. The officer or employee submits the rates to the governing body by Aug. 7 or as soon thereafter as practicable.

School districts do not use this form, but instead use Comptroller Form 50-859 Tax Rate Calculation Worksheet, School District without Chapter 313 Agreements or Comptroller Form 50-884 Tax Rate Calculation Worksheet, School District with Chapter 313 Agreements.

Water districts as defined under Water Code Section 49.001(1) do not use this form, but instead use Comptroller Form 50-858 Water District Voter-Approval Tax Rate Worksheet for Low Tax Rate and Developing Districts or Comptroller Form 50-860 Developed Water District Voter-Approval Tax Rate Worksheet.

The Comptroller's office provides this worksheet to assist taxing units in determining tax rates. The information provided in this worksheet is offered as technical assistance and not legal advice. Taxing units should consult legal counsel for interpretations of law regarding tax rate preparation and adoption

SECTION 1: No-New-Revenue Tax Rate

The NNR tax rate enables the public to evaluate the relationship between taxes for the prior year and for the current year based on a tax rate that would produce the same amount of taxes (no new taxes) if applied to the same properties that are taxed in both years. When appraisal values increase, the NNR tax rate should decrease.

The NNR tax rate for a county is the sum of the NNR tax rates calculated for each type of tax the county levies.

While uncommon, it is possible for

a taxing unit to provide an exemption for only maintenance and operations taxes. In this case, the taxing unit will need to calculate the NNR tax rate separately for the maintenance and operations tax and the debt tax, then add the two components together.

- The voter-approval tax rate is the highest tax rate that a taxing unit may adopt without holding an election to seek voter approval of the rate. The voter-approval tax rate is split into two separate rates:

 1. Maintenance and Operations (M&O) Tax Rate: The M&O portion is the tax rate that is needed to raise the same amount of taxes that the taxing unit levied in the prior year plus the applicable percentage allowed by law. This rate accounts for such things as salaries, utilities and day-to-day operations.
- 2. Debt Rate: The debt rate includes the debt service necessary to pay the taxing unit's debt payments in the coming year. This rate accounts for principal and interest on bonds and other debt secured by property tax revenue.

The voter-approval tax rate for a county is the sum of the voter-approval tax rate calculated for each type of tax the county levies. In most cases the voter-approval tax rate exceeds the no-newrevenue tax rate, but occasionally decreases in a taxing unit's debt service will cause the NNR tax rate to be higher than the voter-approval tax rate.

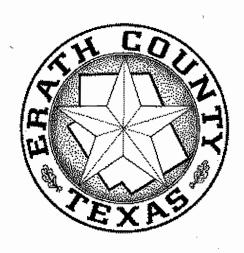

- Index and scan the remaining Miscellaneous records into Tyler software
- Image Birth and Death records that are not in the Tyler system
- Image Marriage Records that are not in the Tyler system
- Image All Military Discharge Records that are not in the Tyler system
- Image Civil records that are not in the Odyssey System.
- Review the paper files in our possession and determine their condition, begin preservation of those records based on need from worst to least.
- Take inventory of damaged volumes and categorize them by need for repair and prepare a plan to have books repaired from worst to least.

Summary

The Legislature provided this "user" fee as a means to raise revenue for the records management and preservation of records in the possession of the county clerk. This "user" fee is an alternative to raising taxes or spending general fund monies to accomplish these projects.

The vast majority of the permanent records in the County Clerks office are paper based. These records are used on a daily basis by the public and are vulnerable to loss by theft and wear and tear. The records management and/or archive fees collected can be used to cover both the cost of scanning the paper-based documents and preserving the handwritten books.

Having a digital record preserves the original record because the original record is handled less. Having a digital record also improves access to the record. One is no longer required to go to the basement to pull the paper book, it can be located and viewed on a public access terminal in the office or from home via the internet at any time. Our digital records are backed up offsite, in the event of a disaster or other type of loss or damage they can be duplicated. Records that have been worn or damaged over time can be repaired.

With the use of the available funds we have completed the following:

- Purchased and provide annual maintenance of Tyler Eagle Software.
- Upgraded software so that all of our land indexes, documents and vital indexes can be viewed on our county website.
- Digitized our land records indexes
- Scanned and indexed by volume and page all of the Deed, Real Property, and Oil & Gas Records.
 (Sovereignty land records from 1876 to present)
- Uploaded Deed of Trust records into the Tyler Software
- Property Index Books have been scanned and recreated into smaller, more useable volumes.
- Birth, Death and Marriage Records have been indexed. Historic records are being scanned and added daily.
- Military Discharge Records (DD214) have been indexed.
- Criminal Misdemeanor Records have been indexed and scanned. (1960's)
- Civil Records and Probate Records from 1967 to present have been indexed and scanned.
- Replaced/or rebound or repaired various volumes as needed
- Purchased new roller shelving for records when the new building was completed
- Records in the Tyler System are transferred multiple times daily to Tyler's off-site data base as a part of our disaster recovery plan.
- Migrated the historic conversion indices and images completed in previous project into the Tyler software. This
 made all index entries searchable by volume and page. This makes records available for both in office and online
 searches.
